## **Privacy Policy for California Consumer Privacy Act**

Sanrio Company, Ltd. ("Sanrio") may have occasion to collect and process personal information. If you are a California "consumer" within the meaning of the California Consumer Privacy Act of 2018 ("CCPA"), this Privacy Policy for California Consumer Privacy Act ("CCPA Privacy Policy") applies to you.

#### 1. <u>Sanrio's Collection, Use, and Disclosure of Personal Information</u>

# A. Categories, Sources, and Purposes of Your Personal Information Collected or to Be Collected

#### 2. <u>Your Rights and Requests</u>

If you are a California consumer, you have certain choices regarding your personal information, as described below:

- I. <u>Access:</u> You have the right to request, twice in a 12-month period, that Sanrio disclose to you the following information Sanrio has collected, used, and disclosed about you during the 12 months preceding your request:
  - (I) The categories of personal information Sanrio collected about you;
  - (II) The categories of sources from which Sanrio collected such personal data;
  - (III) The business or commercial purpose(s) for collecting such personal information about you;
  - (IV) The categories of third parties with whom Sanrio shared such personal information; and
  - (V) The specific pieces of personal information Sanrio has collected about you;
- II. <u>Deletion:</u> You have the right to request that Sanrio delete certain personal information Sanrio collected from you.

**Verifying Requests.** To help protect your privacy and maintain security, Sanrio will take steps to verify your identity before granting you access to your personal information or complying with your deletion request.

Upon receiving an access or deletion request from you, Sanrio will first verify your identity by requiring you to submit information necessary to verify your identity, such as your name and e-mail address, depending on the service provided, and by matching the information you provide with what Sanrio already has on file.

If you use an authorized agent to make an access or deletion request on your behalf, Sanrio may require you to (1) provide the authorized agent signed permission to do so, (2) verify your own identity directly with Sanrio (as described above), and (3) directly confirm with Sanrio that you provided the authorized agent permission to submit the request.

Additional Information. If you choose to exercise any of your rights under the CCPA, you have the right to not receive discriminatory treatment by Sanrio. To the extent permitted by applicable law, Sanrio may charge a reasonable fee to comply with your request.
